Definitions

Day	All day measurements are in calendar days.
Licensing	
Processing time	Number of days from completion date and the license issued date. Completion date is the date the final piece of documentation required for the application is received.
Total number of applications processed	Number includes renewals, exam, endorsement, temporary license, advanced practice recognition, temporary recognition, prescriptive authority, reinstatement, return-to-active, modification of license, duplicate application, licensure verifications.
Investigations	
Average number of days for case investigation	Number of days from time case is opened until investigation is completed (case closed by investigator or 1st notice for hearing).
Average number of days for case resolution	Number of days from time case is opened until case resolved by Board Hearing.
Peer Assistance Program	
Number of discharges	Number of Peer participants who successfully complete the program.
Number of terminations	Number of Peer participants who leave the program prior to successful completion.
Average number of days from Peer program application to entry	Time calculated on applicants who have active licensure status (does not include applicants referred by the Board who do not have active licensure status).
Average number of days from termination to licensure action	Number of days from date of Peer termination until licensure status is changed by Board staff (suspension for voluntary entry; revocation for Board Order entry).
Recidivism rate	Percentage of Peer participants successfully completing the program who are later identified with further substance problems either through return to the program or board action. Population includes all participants since November 1994.
Relapse rate	Percentage of Peer participants who fail to remain abstinent based on the number of Peer cases/year.
