**3.0 Verbal reports requiring no action by committee**

**3.1 Board of Nursing update:** G. McNish reported that, at the July 2011 Board meeting, the Board approved revisions to *Moderate (Conscious) Sedation Guidelines for Registered Nurse Managing and Monitoring Patients*, #P-06, and the *CRNA Inclusionary Formulary*, #P-50A.

**3.2 Amendments to the Oklahoma Nursing Practice Act:** J. Ward reported that the amendments to the *Oklahoma Nursing Practice Act* were passed by the Legislature and signed by the Governor in Spring 2011. She provided a summary of the amendments and reviewed the primary changes. The amended *Oklahoma Nursing Practice Act* will take effect November 1, 2011.

**3.3 Revisions to the Rules of the Oklahoma Board of Nursing:** G. McNish reported on revisions to the *Rules of the Oklahoma Board of Nursing*. The revised *Rules* took effect July 1, 2011.

**4.0 Review and discussion of proposed revisions to Rules of the Oklahoma Board of Nursing related to advanced practice registered nursing:** Proposed revisions to the Rules of the Oklahoma Board of Nursing related to advanced practice registered nursing were provided in the agenda packets. G. McNish reviewed substantive changes with the committee members. No recommendations were made for additional changes.

**5.0 Review and committee recommendation on revisions to National Certifying Bodies and APN Certification Examinations Approved by the Oklahoma Board of Nursing, #P-52A**

**and National Certifying Bodies and Non-APN Certification Examinations Approved by the Oklahoma Board of Nursing, #P-52B:** Copies of the policies, information on the transfer of the Advanced Diabetes Management Program to the American Association of Diabetes Educators, and information from a consortium of certifying bodies on current and planned certification programs were provided in the agenda packet. After discussion, it was moved (S. Jones) and seconded that the following revisions be recommended to the Board:

- 1) Move the Advanced Diabetes Management Clinical Nurse Specialist certification program (#61) to *National Certifying Bodies and Non-APN Certification Examinations Approved by the Oklahoma Board of Nursing, #P-52B*.
- 2) Add language to *National Certifying Bodies and APN Certification Examinations Approved by the Oklahoma Board of Nursing, #P-52A* to indicate that, effective January 1, 2016, the Advanced AIDS Certified Registered Nurse (#63) and the Advanced Oncology Certified Clinical Nurse Specialist (#68) will no longer be recognized as certification programs for new licensure in Oklahoma as Advanced Practice Registered Nurses.
- 3) Update the title of the CRNA certifying body to the current title (National Board On Certification & Recertification Of Nurse Anesthetists).
