- 3.0 Board Update: Verbal reports requiring no action by committee:
 - **3.1. House Bill 2482-Effective November 1, 2016:** J. Ward shared changes to the *Oklahoma Nursing Practice Act* relating to the new Enhanced Nurse Licensure Compact. The new Enhanced Nurse Licensure Compact will become effective when 26 states join or December 31, 2018, the sooner of the two.
 - **3.2** Proposed amendment to the *Oklahoma Nursing Practice Act:* J. Ward summarized House Bill 1886 and proposed changes related to the *Oklahoma Nursing Practice Act*. The *Oklahoma Nursing Practice Act* is open in seven different Bills running this legislative session.
 - **3.3** Revisions submitted for approval for the Rules of the Oklahoma Board of Nursing: J. Ward summarized changes to the Rules of the Oklahoma Board of Nursing submitted for legislative approval. Ms. Ward shared that the current emergency Rules were being moved forward for permanent adoption.
 - **3.4 Board decision on policy revisions**: G. Stafford addressed changes approved by the Board to the following: *Exclusionary Formulary for Advanced Practice Registered Nurses with Prescriptive Authority*, #P-50B, *Limited Obstetric Ultrasound and Limited Ultrasound in a Reproductive Medicine Setting Examination*

Performed by Registered Nurse Guidelines, #P-13, Delegation of Nursing Functions to Unlicensed Persons, #P-02, Licensure Verification and Photocopy of Nursing License, #OBN-02, CRNA Inclusionary Formulary, #P-50A, Advance Practice Registered Nurse (APRN) Certification Examinations Approved by the Oklahoma Board of Nursing, #P-52A, and Advance Practice Registered Nurse (APRN) Certification Examinations NO Longer Approved by the Oklahoma Board of Nursing, #P-52B

3.5 Comprehensive Addiction and Recovery Act of 2016 (CARA): G. Stafford shared the CARA became effective July 22, 2016. The law expands prescribing privileges to nurse practitioners and physician assistants until October 1, 2021. The law does not currently include Clinical Nurse Specialists. Certified Nurse Practitioners must complete 24 hours of training to be eligible for a waiver to prescribe certain medications for medication-assisted treatment. The Drug Enforcement Agency (DEA) will begin to issue waivers in March 2017 to Certified Nurse Practitioners who have completed the training.
