

## HEARINGS AND CONFERENCES

This fiscal year, the Board implemented new language in Board Orders directing **automatic revocations, suspensions or temporary suspensions** when licensees or applicants violate existing Orders of the Board. Listed below are licensees or applicants with suspensions, revocations or temporary suspensions, after the **May, 2005** Board Meetings. **The Subsequent Action taken due to non-compliance by the licensee of an existing Board Order changes the licensure status which may be listed for a licensee or applicant with the May, 2005 Board Hearings or Conferences, which follow the Subsequent Actions list.**

In addition, other suspensions of licenses occur in compliance with Statute 59 O.S. § 567.17.I of the Oklahoma Nursing Practice Act, when a nurse defaults on a contract with the Peer Assistance Program – the nurse impaired program of the Oklahoma Board of Nursing. A suspension letter is issued, and no Order is entered until the matter is heard by the Oklahoma Board of Nursing.
