

### HEARINGS AND CONFERENCES

Language in Board Orders directs **automatic revocations, suspensions or temporary suspensions** when licensees or applicants violate existing Orders of the Board. Listed below are licensees or applicants with suspensions, revocations or temporary suspensions, or other actions, after the **November, 2009**, Board Meeting. The Subsequent Action taken due to non-compliance by the licensee of an existing Board Order changes licensure status which may be listed for a licensee or applicant with the November, 2009, Board Hearings and Conferences, which follow the Subsequent Actions list.

In addition, other suspensions of licenses occur in compliance with Statute 59 OS § 567.17I of the Oklahoma Nursing Practice Act, when a nurse defaults on a contract with the Peer Assistance Program a suspension letter is issued, and no Order is entered until the matter is heard by the Oklahoma Board of Nursing.
