Secretary Doerflinger extended his apologies to the agency and the Board for its experiences over the last 20 months and commitment of OMES to addressing issues identified in the audit.

Mr. Reese shared the intent of OMES-ISD is to provide the services and security as agreed upon. He indicated that the updates to agency IT policies and disaster recovery plans should be timely provided at no charge to the agency. Mr. Reese also conveyed his apologies, and those on behalf of Secretary Doerflinger, and reported that OMES-ISD will provide a plan of action to be presented to the Board at the November 2013 Board Meeting.
