3.1 Board of Nursing update

3.1.1 Review of Recent Policy Revisions: G. Stafford addressed changes to the *Advance Practice Registered Nurse (APRN) Certification Examinations Approved by the Oklahoma Board of Nursing, P#52A*. G. Stafford also reviewed additional language added to *Registered Nurse Administering, Managing and Monitoring Non-Obstetrical Patients Receiving Analgesia by Catheter Techniques, #P-03* and *Registered Nurse Monitoring Obstetrical Patients Receiving Analgesia/Anesthesia by Catheter Techniques, #P-04*.

3.1.2 Review of revisions of the Rules of the Board: J. Ward presented the revisions to the *Rules* allowing for APRNs to reinstate by passing a certification examination.

3.1.3 Amendments to the Oklahoma Nursing Practice Act: J. Ward reported on amendments to the *Oklahoma Nursing Practice Act*, which will take effect November 1, 2014.

3.1.4 Revisions to the CRNA Inclusionary Formulary: G. Stafford reported on revisions to the CRNA Inclusionary Formulary, which were recommended by the CRNA Formulary Advisory Council and approved by the Board in May 2014.

3.2 Other Reports:

3.2.1 Review of House Bill No. 1020: G. Stafford reported on the revisions to the Physical Therapy Act addressing physical therapy orders effective November 1, 2014.

3.2.2 Review of House Bill No. 2554: J. Ward reported on the revisions to the Oklahoma Nursing Practice Act addressing Nursing Education Programs effective November 1, 2014.

3.2.3 Review of House Bill No. 1262: J. Ward reported on the revision to the Oklahoma Nursing Practice Act addressing changes for Licensed Practical Nurse applicants effective November 1, 2014.

4.0 Review and recommendations to the Oklahoma Board of Nursing on the revisions to *Advanced Practice Nurses with Prescriptive Authority Exclusionary Formulary -#P-50B*:

- **Draft revisions proposed by staff:** G. Stafford reported the process for reviewing and revising the *Exclusionary Formulary*. Revision included updating those drugs no longer included in the *2014 American Hospital Formulary Service Drug Information Book*.
- **Discussion regarding Ritalin, Clozapine, and Ketamine:** G. Stafford reported receiving practice calls related to the three mentioned drugs. Ritalin is a schedule II and cannot be ordered by an APRN with prescriptive authority. [63 O.S. § 2-312.C] Warnings for Ketamine and Clozapine were discussed.
- **Discussion and decision regarding Hetlioz and Bunavail:** G. Stafford provided information regarding Bunavail and Hetlioz. Bunavail is the same as Suboxone. Bunavail was added to the *Exclusionary Formulary*. After discussion Hetlioz was not added to the Exclusionary Formulary.
- **Discussion and decision regarding FDA Boxed Warning regarding Lidocaine Viscous:** G. Stafford presented information regarding warning.

After discussion Lidocaine Viscous was not added to the *Exclusionary Formulary*

- **Other recommendations:** Recommendation to add language to the Formulary Advisory Council *Procedure for Amending the Formulary* regarding the *Exclusionary Formulary*. It was moved (D. Booton-Hiser) and seconded that the draft revisions be submitted as presented to the Oklahoma Board of Nursing for approval.
