### NCLEX Pass Rate Report Calendar Year 2014

In Calendar Year (CY) 2014, Oklahoma educated first-time candidates for Registered Nurse licensure achieved an overall 83.55% NCLEX-RN Pass Rate. This is a slight increase from the 83.03% NCLEX-RN pass rate for CY 2013. The CY 2014 Oklahoma NCLEX-RN pass rate is higher than the National NCLEX-RN pass rate of 81.79%.

Approximately 54% of all campuses in Oklahoma, including pre-licensure associate degree and baccalaureate degree nursing education programs, achieved pass rates above the national average. Approximately 19% of the programs achieved pass rates that were more than 10 percentage points lower than the national average. In CY 2014, Oklahoma associate degree and baccalaureate degree programs ranked higher than 31 other states or jurisdictions on the NCLEX-RN exam. There were 2,146 first-time Oklahoma-educated RN candidates taking the NCLEX-RN exam in 2014, which is higher than the 2,080 first-time candidates testing in CY 2013.

In CY 2014, Oklahoma-educated first-time candidates for Licensed Practical Nurse licensure achieved an NCLEX-PN pass rate of 86.94%. Between CY 2004 and CY 2014, Oklahoma-educated first-time NCLEX-PN candidate averages ranked consistently above the national NCLEX-PN average. In CY 2014, approximately 25% of all campuses offering practical nursing education achieved a 100% NCLEX-PN pass rate, and approximately 55% of the practical nursing campuses achieved a pass rate above the national average. In addition, approximately 7% of the practical nursing campuses averaged more than 10 percentage points lower than the national average. Oklahoma practical nursing programs ranked higher than 24 other states or jurisdictions on the NCLEX-PN exam in CY 2014. There were 945 first-time Oklahoma-educated PN candidates taking the NCLEX-PN exam in CY 2014, which is lower than the 1,182 first-time candidates testing in CY 2013.

### Peer Assistance Program

Substance use disorder is a problem that affects a significant portion of our population. According to the 2011 Behavioral Risk Factor Surveillance System (BRFSS) survey, 45.6% of adult Oklahomans had at least one drink during the previous 30 days and 5.5% of adult Oklahomans were heavy drinkers (defined as adult men having more than 2 drinks per day and adult women more than one drink per day.) Additionally, 16.5% of the adult population reported binge drinking (defined as men having more than 5 drinks on one occasion and adult women more than 4 drinks on one occasion.) The National Survey on Drug Use and Health, in 2010, ranked Oklahoma number one nationally for the nonmedical use of pain relievers in the past year for all age categories (12 and above).

Nurses are not immune to problems with substance use. According to the American Nurses Association, it is estimated between 6-8% of nurses use substances to the extent their practice is impaired. In Oklahoma, that would equate to between 4,200-5,700 nurses practicing potentially impaired. If you are a nurse experiencing this problem, you are not alone; perhaps, the Peer Assistance Program can help. The Peer Assistance Program is a program for nurses who are experiencing a problem with the use of substances, whether drugs or alcohol. ## National Transportation Safety Board Safety Recommendations

The National Transportation Safety Board (NTSB) is an independent federal agency charged by Congress with investigating every civil aviation accident in the United States and significant accidents in other modes of transportation to determine the probable cause of the accidents. In consideration of investigative findings, the NTSB issues safety recommendations aimed at preventing future accidents and saving lives.

The NTSB is providing the following information to urge the 50 states, including Oklahoma, the District of Columbia, and the Commonwealth of Puerto Rico, to take action on the safety recommendations noted below.

### Safety Recommendation I-14-1:

Include in all state guidelines regarding prescribing controlled substances for pain a recommendation that health care providers discuss with patients the effect their medical condition and medication use may have on their ability to safely operate a vehicle in any mode of transportation.

### Safety Recommendation I-14-2:

Use existing newsletters or other routine forms of communication with licensed health care providers and pharmacists to highlight the importance of routinely discussing with patients the effect their diagnosed medical conditions or recommended drugs may have on their ability to safely operate a vehicle in any mode of transportation.

This notice, along with an article distributed by the NTSB to fulfill Safety Recommendation I-14-2, was provided via email to Oklahoma-licensed Advanced Practice Registered Nurses with prescriptive authority on December 29, 2014.

## Online Applications

Effective March 2, 2015, Advanced Practice Registered Nurse initial applications, Prescriptive Authority initial applications and Reinstatement applications are available primarily as online applications. This transition supports the "Go Green" direction of state government, contributes to efficiencies within the Board of Nursing, and promotes lower application processing times.

All applications have been available online since 2009. Since this time, the Board has seen a marked improvement in processing times of applications and improved stakeholder satisfaction.

For those applicants who do not have personal access to a computer through home, work, school or a nearby library, computers are available for public use in the Board office. If an applicant cannot access an online application by any of these means, a paper copy may be requested by the individual applicant by submitting a written request for such to the Board office. A self-addressed, postage-paid (approximately \$1.06) 8 ½" x 11" envelope must accompany the written request for a paper copy of the application.
